FEDERATED AUDIT COMMITTEE

1. Consent Calendar

- a. Approval of the Minutes of the Special Federated Audit Committee meeting from January 19, 2023.

A motion was made to approve the Consent Calendar.

FCERS Committee Approved. (M.S.C. Keleher/Jennings 3-0-0) The motion passed unanimously by roll call vote.

2. New Business

- a. Discussion and action on factual findings for use of California Assembly Bill 361's abbreviated teleconferencing procedures.

Counsel Chin spoke to the item and explained the contents of the memo submitted to the Committee regarding evidentiary support for the Committee consideration of factual findings necessary for election to adopt AB 361's abbreviated teleconferencing procedures, which included:

(1) Governor's proclamation on the continued state of emergency due to the ongoing COVID 19 pandemic; and

(2) the City Council's recent resolution that continued to impose and recommend social distancing in City facilities.

A motion was made to adopt these as the Committee's factual findings under AB361 to allow the Committee to continue meeting virtually for the next 30 days.

Approved. (M.S.C. Jennings/Avasty 3-0-0) The motion passed unanimously by roll call vote.

Mr. Boussina explained that the ORS Internal Auditor Charters required to meet and exceed the Institute of Internal Auditor's standards. The Internal Staff Survey reported incident of fraud to be prioritized for audit.
