RECOMMENDATION

Discussion and action to amend prior September 5, 2024, motion to authorize CEO to negotiate and execute a First Amendment with Saltzman & Johnson Law Corporation to increase the not to exceed amount by \$250,000 (i.e. from \$500,000 to \$750,000) through the end of the current term of June 30, 2025.

BACKGROUND

On September 5, 2024, the Police and Fire Department Retirement Plan Board ("Board") authorized the CEO to negotiate and execute a first amendment to the agreement with Saltzman & Johnson to increase the amount by \$250,000 to \$600,000. Due to administrative error, the memorandum incorrectly stated that the current contract with Saltzman & Johnson was for a not-to-exceed amount of \$350,000. This memorandum corrects the original not-to-exceed amount of the contract for the Police and Fire Retirement Plan to \$500,000.

The Office of Retirement Services ("ORS") contracts with Saltzman & Johnson to perform essential legal services for disability retirement processing, DROs, and miscellaneous services for conservatorships, powers of attorney, small estate affidavits, guardianships, and income withholding orders. Saltzman & Johnson also provides other legal services directly for the Board.

Below is the timeline of the current contract with Saltzman & Johnson:

• On May 7, 2020, the Board of Administration for the Police and Fire Department Retirement Plan ("Board") authorized the CEO to negotiate and execute a contract with

Saltzman & Johnson, not to exceed \$500,000, for DRO and disability legal services with a term ending June 30, 2025.

ANALYSIS

Saltzman & Johnson performs essential legal services for pension benefit administration including disability retirement processing. Since the execution of the contract with Saltzman & Johnson in 2020, ORS has significantly increased disability retirement activities. As a result, legal services for disability retirement processing have been higher than anticipated. Additional funding is needed to continue essential legal services for pension benefit administration through the term of the contract.

In October 2022, ORS implemented a new, streamlined disability application process which has enabled staff to process a higher number of disability retirement applications, making significant progress on a backlog of about 140 disability applications. In 2021, ORS processed about 13 disability retirement applications. In 2024, ORS anticipates processing over 50 disability retirement applications. This is a significant increase in disability application processing over the past several years.

With the higher number of disability applications processed, disability processing legal services from Saltzman & Johnson has increased significantly. In 2021, disability-related legal services were averaging about \$3,700 per month. During the past six months, disability-related services have averaged about \$22,500 per month, which is about 8 disability retirement applications per month (legal services for a typical disability is \$2,680). While ORS does not anticipate that this level of monthly expenses will continue indefinitely, ORS expects that it will continue through the term of the contract in June 2025, at a minimum, as ORS addresses the backlog of disability retirement applications.

Funding for legal services for DROs and miscellaneous are also required through the term of the contract. ORS anticipates reaching the not-to-exceed amount of the contract in August 2024. The table below outlines the detail of the additional funding being requested through June 30, 2025, the term of the contract. No funding has been added for other legal services for the Board as no expenses of this type are anticipated.

Saltzman & Johnson performs essential legal services for pension benefit administration. With funding expected to be exhausted on the contract in August 2024, staff recommends authorizing the CEO to negotiate and execute a first amendment to the contract between the Board of Administration for the Police and Fire Department Retirement Plan and Saltzman & Johnson to increase the not-to-exceed amount by \$250,000, from \$500,000 to \$750,000.
