 - **II. OPEN SESSION:** Discussion and action on interpretation and implementation of SJMC § 3.36.3660 to affected members.

Maytak Chin, General and Fiduciary Counsel, spoke on the item. Counsel Chin explained SJMC § 3.36.3660, which is the provision that divides disability benefits when members have

Domestic Relations Order establishing a separate account for the member's alternate payee(ex-spouse or ex-domestic partner), a SADRO. Harvey Leiderman, General and Fiduciary Counsel, presented the text of SJMC § 3.36.3660 regarding the allocation of disability benefits between the participant and the alternative payee with a separate account. Counsel Leiderman introduced the tax specialist, Jenni Krengel from Buchalter Law Firm who spoke to the item. Counsel Chin and Counsel Leiderman answered questions from the public and the Board. Trustee Wilson presented the recommendation of the Ad Hoc Committee, to adopt the revised interpretation of SJMC § 3.36.3660 as presented by fiduciary and tax counsel, consistent with the Plan's treatment since the adoption of the Code section.

A motion was made to adopt the Ad Hoc Committee's recommendation and to direct staff to take the necessary measure to implementing this interpretation of SJMC § 3.36.3660.

Members of the public and the Board spoke to the motion.

Approved. (M.S.C. Santos/Wilson 8-0-0) The motion passed unanimously by roll call vote. Chair Lanza was absent.
