Good morning, Martin. Michelle Saechao is your assigned analyst, but she is currently out for the Holiday closure. We wanted to provide you as much time as possible to review and complete your forms. Michelle will be available to assist you after 01/02/2023. Please review/sign/return your Notice of Separation as soon as possible. We will provide to your department for additional signatures. We cannot accept electronic signatures on any paperwork, apologies for any inconvenience. Be sure you do not have any hours recorded on or after your retirement date.

Please note the forms included with the email from Marivic today are not the complete packet. Rather these are updated forms to replace some of what you were provided on 12/22/2022 via email. The rest of the forms are correct and should be completed and returned.

You are scheduled for group counseling via Zoom on Tuesday 01/03/2023 at 9:30 a.m. – an invitation will be sent either the Friday or Monday before the session. At group counseling we will review all documents and answer questions. There is one document that your spouse must either sign in front of staff or have notarized – Annuity Designation form. Witnessing will be available at group counseling.

For a quick overview and some important information – pension payments are issued

once a month on the last day of the month. Your first payment will pay retroactive to your retirement date. You will have multiple insurance deductions on your first check as premiums are deducted in advance (i.e. August deduction pays September premium). Insurance is effective retroactive to the first of the month following your retirement (for you, 02/01/2023) and will not be reported to the vendors until setup (in your case, mid-March). We need all paperwork completed and returned – nothing transfers over from your active employment.

Please let me know if you have questions or if you are unable to attend group counseling.
