## CEO's Message From John Flynn



As we enter the fourth quarter of the year, I find myself reflecting on my first year—it has been both eventful and rewarding. Hard as it is to believe, I am already preparing for my second Open Enrollment since joining ORS.

Open enrollment this year is somewhat paradoxical. On one hand, the changes to the

plans are minimal: no change in our vendors – Kaiser Permanente and Anthem will continue to provide coverage for our members. On the other hand, while our health benefit providers remain the same this year, the unfortunate news is that some plans—including Medicare—will see significant rate increases. See the related article for details.

In the case of Anthem Medicare Senior Advantage, this unavoidable increase means members enrolled in this plan will have the monthly premium deducted from their pension checks beginning January. 1, 2026.

In addition, for Police and Fire retirees eligible for the Medicare Part B reimbursement enrolled in the Anthem Medicare Senior Advantage plans, we regret to report that the reimbursement will no longer be available because of the rate increases.

As always, our staff has prepared a variety of resources to help members make informed choices during Open Enrollment. Please see the related articles in this issue for details. On another front, this past September, the Boards each held strategic planning retreats. Topics discussed included CyberSecurity, Investments and Strategic planning. ## **Open Enrollment Resources**

ORS has arranged for a suite of tools and resources to help members make informed decisions during November Open Enrollment. Both Anthem and Kaiser Permanente will host online webinars focused on plan information for pre-Medicare (early retirees) and Medicare enrollees. ## **Quarterly Question**

Do I Really Need to Enroll in Medicare Part B?

Yes — All medical eligible members and dependents age 65 and older must enroll.

If you or your dependents are age 65 or older enrolling in a City of San José Medicare plan, enrollment in Medicare Part B is required. Unlike Medicare Part A, which is typically premium-free, Part B requires a monthly premium that must be paid directly to Medicare. Failure to pay your Medicare Part B premium—or losing Part B coverage for any reason—will result in termination of your City of San José Retiree medical plan.

### To Maintain Uninterrupted Coverage:

- Keep your Medicare Part B enrollment active
- Pay your Medicare Part B premiums on time

They can assist with providing you the information you need to make your Open Enrollment selections for 2026.

Also, ORS staff will host Medicare workshops in partnership with Kaiser and Anthem and be present to explain how to navigate Medicare.

This year, there will be free Biometric Screening and Derma Scans available, along with varied information on how to live healthy, happy retirement lives. Bring an appetite! ORS is hosting a bake sale and there will also be a food truck onsite for lunch (the back patio will be open to enjoy your food purchases).

## Highlights for this year's Open Enrollment and rate changes

Non-Medicare plan rates will see increases ranging from 0.29% to 10.63% for 2026. There are more significant, unavoidable cost increases for Medicare plans, with a notable change for Police & Fire members. Here are the key points:

- There will be no change in our insurance carriers for 2026, with members still able to choose between Kaiser Permanente (in designated service areas) and Anthem (nationwide).
- Anthem PPO premiums will increase by 0.29 percent, or just more than ¼ of one percent.
- Anthem HMO plan rates will increase by 2 percent.
- Kaiser plan rates will increase by 10.63 percent.
- Medicare Senior Advantage plans will have higher increases, with Anthem increasing by 34.85 percent and Kaiser by 12.88 percent.
- Due to the significant increase in the Anthem Medicare Senior Advantage rate, members enrolled in this plan will have a monthly premium deducted from their pension checks starting Jan. 1, 2026.
- A NEW Anthem Medicare Senior Advantage plan will be added at a lower monthly premium by adding a \$75 copay for Emergency Room visits. Members who enroll in this plan will also have a monthly premium deducted from their pension checks starting Jan. 1, 2026.
- For Police & Fire members eligible for a Medicare Part B reimbursement, unfortunately, with the 2026 Anthem Medicare rate increases, the monthly premium will now exceed what the plan will subsidize (the lowest cost plan), resulting in an out-of-pocket premium for the member, therefore no remaining funds to reimburse. This is disappointing news, but unavoidable. For Police and Fire members eligible for a Medicare Part B reimbursement, who are enrolled in Kaiser Senior Advantage plans will continue to have funds available for reimbursement.
- Beginning in 2026, the VSP and Choice vision plans will be combined into one plan with enhanced benefits. The new plan will include LightCare lenses (for sunglasses and blue light protection), polycarbonate lenses, and new frames every 12 months, with no premium increase for the 2026 Choice plan rate.
