Chair Ganapati and Chair Avasthy introduced the item and stated the desire for a clear systematic approach to audit issues. The Chairs stated that they would like the Senior Internal Auditor to draft a proposed Annual Audit Plan for FY 2024-2025 with ORS Management to present to the Joint Audit Committee for review and input for approval.

The Committee further directed Counsel to remove the word "Flexible" from the Internal Auditor Charter when describing the Audit Plan so that there is a definite and disciplined approach to addressing audit issues. Counsel Chin made a few comments. Chair Ganapati and Chair Avasthy answered questions from the Committee.

A motion was made to approve the proposed direction for the Annual Audit Plan and for the removing of the word flexible from the Internal Auditor Charter.

**a.** Update from the City Auditor, Joseph Rois.

Joseph Rois, City Auditor, presented the item and updated the Committee with the City Audit Report. Mr. Rois, Counsel Chin and CEO Peña answered questions from the Committee. Chair Ganapati, CEO Peña and Trustee Jennings thanked Mr. Rois and his team for their work and made a few comments.

b. Discussion and action on request to custodial bank (Bank of New York Mellon) to correct fiscal years 2016-2023 Pension Plans returns based on the results of the Agreed Upon Procedures work completed by Macias Gini & O'Connell LLP audit firm.
