

Market Update



Market Update – Q2 2016

Economy

In April, risk assets broadly moved higher supported by a recovery in commodities, but there was continued caution from the Fed over the future US rate rises. The S&P 500 TR returned +0.4% and MSCI AC World was up +1.5%. However, the market was disappointed by the BoJ failing to ease further and the Nikkei retraced intra-month gains of 4.8% to end the month down 0.55%. US corporate credit had a very strong month with the Bloomberg USD HY index up 3.9% on the back of a rebound in oil prices, while US IG debt was positive up 1.36% as measured by the Bloomberg USD IG Debt index.

In May, US economic data was strong and inflation was at the highest level for three years, supporting a decline in volatility and an increase in risk assets. Developed equity markets were positive, EM was down hurt by a strengthening USD, commodities were mixed with Gold and Silver declining and Oil strengthening on surprise supply shortages. US Treasury yields rose while European yields continued to fall further.

June saw significant volatility as British voters opted to leave the EU. Demand for safe haven assets increased driving gains for precious metals and the yen in particular, while most bond yields fell and the resulting demand for yield drove appreciation for many EM equities and currencies.

Hedge Funds

April continued to be challenging for a number of strategies, including quant oriented strategies who were hurt by sharp reversals, and CTAs who were hurt as commodities rallied and the USD weakened. On the positive side, Macro funds benefitted from positions in gold and Brazilian rates, and Relative Value Credit had the average fund up over 1% with the broader HY market up nearly 4%. The shorting environment was improved for US equity long/short funds as we saw funds positioning more single name shorts.

May was a mixed month for hedge funds. Multi-Strategy managers had a fairly strong month up about 1.3%, while CTAs had a difficult month with currency being the biggest detractor. The stock picking environment continues to be beneficial for equity long/short managers and there was wide dispersion in returns for May; however, due to a lack of interesting opportunities managers long books are much more concentrated than they have historically been.

In June, CTAs were the bright spot benefitting from the Brexit volatility. There was a lot of dispersion in most strategies with a wide range of outcomes also as a result of the volatility. In the Albourne universe, Macro funds as well as Multi-Strategy Diversified and Fixed Income Relative Value funds were on average positive for the month. Equity Long/Short and Structured Credit managers were on average negative.



- Relative Value and Directional/Macro are the dominate strategies in the new Absolute Return construct
- The portfolio has reached its targeted strategy balance. It is likely to move through out the range as opportunities to include additional diversifying funds arise.
- Equity Long/Short and Event Driven exposures result from the Multi-Strategy fund allocations. However, the Multi-Strategy exposure will be reduced slightly with an expected rebalance.

- Pharo, an emerging market macro manager, was funded April 1st
- An investment in AHL Frontier, a diverse CTA fund, was made July 1st
- A single strategy relative value fund is currently being evaluated for inclusion in the portfolio and will likely be brought forward for approval before year end
- Additional complementary opportunities are continually being assessed and will be brought forward if appropriate
