**3.** Presentation on Tail Risk Hedging by Janus Henderson.

Mr. Myron Scholes and Mr. Ashwin Alankar from Janus Henderson gave a presentation on tail risk hedging. The discussion included various risks in the equity market and ways to manage these risks. They also talked about the use of options as a way of building a hedge against risk in the equity market. They believe risk management should be proactive, not reactive. At the end of presentation, they answered questions from the trustees.

**4.** Presentation of Manager Due Diligence by Jay Kwon, Senior Investment Officer.

Senior Investment Officer Jay Kwon provided some context for manager decisions made during the first half of 2020. Decisions are made using authority delegated by the Board outlined in the IPS. The discussion centered around the process that staff used to come to the decision of selecting the Columbia High Yield Bond and the Mellon High Yield Beta strategies.
