## RECOMMENDATION

That each of the Boards' governance charters and policies be amended to require that they be reviewed at least every five years rather than at least every three years.

## **BACKGROUND & DETAILS**

Currently, each of the Boards' governance charters and policies contains a requirement that they be reviewed at least every three years. The charters and policies have been reviewed with such frequency for approximately the past 10 years; i.e. each document has been reviewed at least three times. Recently, reviews have resulted in very few material changes, and most changes were simply intended to create greater consistency between the two sets of documents across the two Boards

Staff and Cortex believe a minimum three-year requirement is now excessive and recommend changing the minimum required review to five years. This would:

- a) Reduce the burden on the Boards, committees and staff, and allow them to focus their efforts elsewhere; and
- b) Reduce the need for consulting resources.

Such a change would not preclude either board from reviewing and amending any governance charter or policy *more* frequently than every five years, if it felt it were necessary.

Accordingly, Staff and Cortex submit the following recommendation for the Joint Governance Committee's consideration:

That each of the Boards' governance charters and policies listed below be amended to require that they be reviewed at least every five years rather than at least every three years:

- 1. Board of Administration Charter
- 2. Board Chair Charter
- 3. Board Vice-Chair Charter
- 4. Counsel Representative to the Board Charter
- 5. Audit Committee Charter
- 6. Governance Committee Charter
- 7. Investment Committee Charter
- 8. Joint Personnel Committee Charter
- 9. CEO Charter
- 10. CIO Charter
- 11. Board Communications Policy
- 12. Board Education Policy
- 13. Board Operations Policy
- 14. Board Performance Assessment Policy
- 15. Code of Conduct
- 16. Gift Policy (this policy currently contains no review requirement)
- 17. Monitoring and Reporting Policy
- 18. Policy on Election of Board Officers
- 19. Policy Regarding Roles in Vendor Selection
- 20. Strategic Planning Policy

The table on the next page summarizes the timing of the next review for each charter and policy under the current and proposed review frequencies.

We look forward to discussing the above at the upcoming Joint Governance Committee meeting.
