2. Oral Update by CIO, Prabhu Palani.

3. Overview of Public Equity by Christina Wang, Investment Officer.

Investment Officer Christina Wang presented the public equity plan. The overview included a review of the objectives of the public equity plan, a summary of the public equity portfolio, market update, and a manager review. The objective of public equity is to provide the plan exposure to public equity and to outperform weighted benchmarks. In terms of risk management, the goal is to minimize volatility. She also discussed portfolio construction and the manager selection process.

4. Risk Overview by Verus Investments.

Ms. Eileen Neill and Mr. Danny Sullivan from Verus Investments discussed the risk analysis of the portfolios. They gave an overview of the risk perspective in the market environment and risk attributes of the portfolio. The portfolio volatility remains in line with policy. At the end of the discussion, Ms. Neill and Mr.Sullivan answered questions from the Committee.
