RECOMMENDATION

Change the retirement effective date from September 4, 2021 to September 18, 2021 for Ms. Rhodora Macaraeg, Senior Engineering Technician from Public Works Sanitary Division.

BACKGROUND

At the August 19, 2021 Board meeting, the Federated City Employees' Retirement System Board of Administration approved the service retirement date of Ms. Macaraeg effective September 4, 2021.

Retirement Services received email notification on August 19, 2021 from Ms. Macaraeg indicating she would like to postpone her retirement and continue working to be eligible to receive the retroactive pay raise that was recently awarded due to the new Union Contract. Per OER, employees must be on pay status for the pay period ending 09/18/2021 to be eligible to receive the retroactive pay. Ms. Macaraeg is delaying her retirement by one pay period to receive the retroactive raise and have that amount included in her final average salary calculations, which impact her retirement benefit.

Ms. Macaraeg is requesting that the Board approve the request to change her retirement date from September 4, 2021 to September 18, 2021.
