2. Oral Update by CIO, Prabhu Palani

CIO Palani presented today's agenda items.

3. Overview of public markets by Senior Investment Officer, Jay Kwon

Senior Investment Officer, Jay Kwon, presented a comprehensive review of public markets. Mr. Kwon discussed in his presentation all the portfolio activities of the prior year. He noted that there was no prefunding by the City for the Federated Plan this year. He also reviewed the workplan for the upcoming year. Mr. Kwon also discussed manager turnovers and

strategy performance as well as the immunized cash flow strategy.

**4.** Discussion and action on the revised Investment Policy Statement for San Jose Federated City Employees' Retirement System

Senior Investment Officer Jay Kwon and Eileen Neill, Verus Investments presented the changes to the Investment Policy Statement. These changes were discussed and questions from the Committee were answered. After the discussion, the changes to the IPS were recommended for approval at the next Board meeting.

A recommendation was made for approval of the changes to the IPS (M.S.C. Horowitz/Faulkner Approved 3-0)

**5.** Risk report by Verus Investments

Eileen Neill, Verus Investments, gave a risk overview of the portfolio. She noted that the total risk remains elevated but below the risk limit of 12%. The high utilization of passive strategies in public markets keeps overall relative and active risk low.

**6.** Macro overview by Clock Tower Group

Mr. Marko Papic from ClockTower Group gave a comprehensive outlook on macro and geopolitical events. Mr. Papic discussed the investments opportunities and risks given the global outlook. He answered questions from Committee members after the presentation.
