Chair Druyan of the Federated Investment Committee and Chair Sunzeri of the Police and Fire called the meeting to order at 12:18 p.m.

OPEN SESSION

1. Minutes of the June 28, 2016 Joint Investment Committee Meeting.

A Motion was made to approve the June 28, 2016 Minutes of the Joint Investment Committee.

2. Presentation and discussion on Public Equity Tactical Asset Allocation update.

Mr. Kwon led the discussion and answered questions from the Trustees regarding his memorandum to update the Plan's Investment Committee (IC) with the performance of the current Public Equity Tactical Asset Allocation (TAA), note changes in market conditions since the last update, and highlight changes to the new target TAA.

Lisa Needle of Albourne was available for questions.

Mr. Kwon outlined the current TAA for the Plan, and resulting performance over the TAA's prior 12-month period (July 2015 - June 2016). The economic basis for the current TAA is reviewed, along with the expected risk/reward tradeoff. The memorandum concluded by proposing no changes to the current target TAA.

This item was for discussion only; there was no action required.

Chair Druyan acknowledged Staff for a job well done.

The item was noted and filed.

3. Presentation of 2nd Quarter 2016 Absolute Return Program by Albourne America.

Lisa Needle from Albourne America led the discussion and answered questions from the Trustees regarding the 2nd Quarter 2016 Absolute Return Program.
