3. Update on the City Auditor's Recommendations to the Office of Retirement Services.

**Roberto Peña, CEO gave an update and answered questions from the Committee on the City Auditor's Recommendations to the Office of Retirement Services. He reported there are 2 items that are part of the budget: 1) the upgrade of the website/newsletter, 2) performance measures. He has shared updates on the progress of the recommendations with the City Auditor.**

4. Update on the Pension Administration System.

**Barbara Hayman, IT Manager and Sue Ziegler, L.R.Weschler, gave a quarterly update and answered questions from the Committee on the Pension Administration System. Ms. Hayman reported the last update was in October. Since then the systems were run parallel for 3 months and ORS went live with the new system on February 4, 2019. Ms. Ziegler reported the remaining items to be completed are Deliverable 5-Member Direct and Measure F. Fed Payroll has balanced and is ready to post. Staff is verifying Police & Fire COLA and are still working through issues with files sent to 3rd parties after payroll. Work arounds are in place so information can be delivered to those vendors and checks should go out as scheduled. Activities for the next 90 days include complete testing/training for Member Direct, continue to refine Workflows and Control Sheets and establish dates for Measure F. CEO Peña thanked staff for their work and announced the next update will be in May.**
