-An email was sent to both Boards regarding the Operations of the ORS. Monthly Pensions payments will continue per normal schedule. Retiree payroll went out smoothly and a few staff members were in the office to deliver checks. He thanked he entire staff for their work and engagement.

- -ORS Office remains closed and the stay in place order has been extended to 5/3/2020. The next Board meeting will be held on 5/7/2020, location TBD. With the Market changes, there may be a need for emergency Board meetings.
- On April 14, 2020, CEO Pena will present the Actuarial Valuation to the City Council via Zoom.
- -Staff is still taking Retirement applications.
- -All committee meetings are cancelled. Disability Committee meetings will be held for financial hardship cases only.
- -Next Retirement Working Solutions Group scheduled on April 13, 2020 has been postponed.
- The Joint meeting of the Boards and City Council has been postponed.
- -CalPERS defined Benefit Plan-OER will be bringing a Resolution of Intention to amend the City's CalPERS contract to the City Council. This is the first step in the process that CalPERS has laid out for the ORS Investment professionals. Once they have the resolution approved by City Council, the City will move forward with the final approval of the contract amendment and will change the Municipal Code to allow the ORS Investment professionals to be excluded from the Tier 3 benefit and included into the CalPERS defined benefit plan. They are aiming for a final deadline of mid-May in order to be enrolled into the CalPERS benefit at that time. This will come back to the Board next month with an update.
