1. <u>NEW BUSINESS</u>

a. Approval of the Minutes from the August 10, 2020 Police and Fire Disability Committee meeting.

A motion was made to approve the Minutes from the August 10, 2020 Police and Fire Disability Committee meeting.

2. Application for a Service Connected Disability Retirement

a. Robert Pasquale, Police Officer, Police Department, Request for a Service-Connected Disability Retirement, effective October 1, 2020; 20.90* years of service.

Item 2a was heard after Item 2c.

Stacee Fischer, Benefits Analyst, read the case information into the record. The applicant was present and represented by Attorney Don Novey. Dr. Tierman reported this was a difficult case and more information is needed. Counsel Richeda agreed the case needs more work. Attorney Novey disagreed and spoke to the case presenting evidence in support of his client's request. Mr. Pasquale discussed his past work history to support his case.

A motion was made to recommend approval to the Board for a Non Service-Connected Disability Retirement. This item will be placed on the Consent Calendar of the October 1, 2020 Police and Fire Board agenda. This item will return to the Disability Committee for a Change of Status to a Service-Connected Disability Retirement at a later time.

b. Adam Plares, Police Officer, Police Department, Request for a Service-Connected Disability Retirement, effective October 1, 2020; 12.98* years of service.

Item 2b was heard before Item 2a.

Ms. Fischer read the case information into the record. The applicant was present and represented by Attorney Novey. Dr Tierman reviewed her findings and answered questions from the Committee. Dr. Tierman and Counsel Richeda were in agreement the evidence clearly indicated there was connected contribution which caused impairment. Attorney Novey had nothing to add. Mr. Plares thanked the Committee.

A motion was made to recommend approval to the Board for a Service-Connected Disability Retirement. This item will be placed on the Consent Calendar of the October 1, 2020 Police and Fire Board agenda.

c. Elliott Sagan, Police Officer, Police Department, Request for a Service-Connected Disability Retirement, effective October 1, 2020; 13.19* years of service.

Ms. Fischer read the case information into the record. The applicant was present and represented by Attorney Novey. Dr. Tierman reported this was a difficult case and more information is needed to show work causation. Counsel Richeda agreed. Attorney Novey disagreed and spoke to the case referring to several doctors reports. He stated there was a significant amount of evidence in support of his client's request. Mr. Sagan thanked the Committee and discussed his past injuries/pain management/work history and answered questions from the Committee. Extensive discussion continued. A motion was made to recommend approval to the Board for a Service-Connected Disability Retirement and failed to pass.

A motion was made to recommend approval to the Board for a Non Service-Connected Disability Retirement. This item will be placed on the Consent Calendar of the October 1, 2020 Police and Fire Board agenda. This item will return to the Disability Committee for a Change of Status to a Service-Connected Disability Retirement at a later time.
