The Chair introduced Tom lannucci, Cortex Consulting. Mr. lannucci reviewed the agenda and goals.

Mr. lannucci gave a brief background and answered questions from the Board. He spoke on the Strategic Planning Framework, recent efforts and Board Self-Evaluation results.

Mr. lannucci discussed the Investment function of the Organizational Vision and the Spectrum of Strategic Choices. Jeremy Evnine of Evnine & Assoc. Inc., Laura Wirick and Frank Benham from Meketa Investment Group presented asset allocation methodology and answered questions from the Board.

Mr. Iannucci continued the discussion of Item 2.1c., the Organizational Vision, focusing on Board Governance, Member Service and Human Resources. The Board provided feedback on the Spectrum of Strategic Choices and agreed the current range is B and would like to strive for C as in the attached slides.

Mr. lannucci will work with staff and return at a later date with a modified Mission Statement, a draft Strategic Planning document and a proposed Strategic Plan based on the Board's discussion. CEO Peña will reach out to Cheiron to request a history of how the current funded status was achieved.
