- (2) the City Council's recent resolution that continued to impose and recommend social distancing in City facilities.

A motion was made to adopt these as the Committees' factual findings under AB361 to allow the Board to continue meeting virtually for the next 30 days.

Senior Investment Officer Dhinesh Ganapathiappan and Investment Analyst Sachin Sadana presented the pacing plan which included the year in review, current positioning, and changes in the market environment.
