2. Oral Update from CIO of Retirement Services, Prabhu Palani.

CIO Palani discussed today's agenda items. There was also a discussion on current market

volatility.

3. Overview of public markets by Senior Investment Officer, Jay Kwon.

Senior Investment Officer, Jay Kwon, presented a comprehensive review of public markets with the exception of public equity. Mr. Kwon discussed in his presentation all the portfolio activities of the prior year. He provided a summary of the prefunding and reviewed the workplan for the prior year. Mr. Kwon also discussed manager turnovers and strategy performance as well as the immunized cash flow strategy.

4. Risk overview by Verus Investments.

Eileen Neill, Verus Investments, gave a risk overview of the portfolio. She noted that the total risk remains elevated but below the risk limit of 12%. The high utilization of passive strategies in public markets keeps overall relative and active risk low.
